

## GENERAL TARIFFS

(in force from 1st January 2025 to 31st December 2026)

### 1. PASSENGER FEES

- ✓ For each in transit passenger (Monday to Friday): **€ 8.61/pax**
- For each in transit passenger (Saturdays and pre-holiday days): **€ 8.86/pax**
- For each in transit passenger (Sundays and Holidays): **€ 9.11/pax**
  
- Minimum chargeable per call, regardless of the number di passengers:
  - From Monday to Friday: **€ 2,350.00/call**
  - Saturdays and pre-holiday days: **€ 2,650.00/call**
  - Sundays and Holidays: **€ 2,950.00/call**
  
- ✓ For each disembarking and embarking (Monday to Friday): **€ 17.31/pax**
- For each disembarking and embarking passenger (Saturdays and pre-holiday days): **€ 18.31/pax**
- For each disembarking and embarking passenger (Sundays and Holidays): **€ 19.31/pax**
  
- Minimum chargeable per call, regardless of the number di passengers:
  - From Monday to Friday: **€ 2,350.00/call**
  - Saturdays and pre-holiday days: **€ 2,650.00/call**
  - Sundays and Holidays: **€ 2,950.00/call**
  
- plus, luggage handling/security screening:
  - Monday to Friday: **€ 8.70/pax**
  - Saturdays and pre-holiday days: **€ 9.45/pax**
  - Sundays and Holidays: **€ 10.20/pax**

The above-mentioned tariffs include:

- Supervision and assistance to cruise ship operations
- Ship's stay at dock up to 14 hours (from 6:00am till 8:00pm)
- Security check on passenger and luggage at Security Level MARSEC 1
- Luggage handling from the ship's side hatch (marshalling area) to the terminal (arrivals), for disembarking pax, and from the drop-off point to the ship's hatch (marshalling area), for the embarking pax

### 2. BERTHING FEES FOR SHIP'S STAY AT DOCK OVER 14 HOURS

- Whenever ships carrying out disembarkation, embarkation and transit operations stay at dock more than 14 hours (from 6:00am till 8:00pm), the following extra non-fractionable daily fees will be applicable:  
**€ 5.80/ship's LOA in meters/day (24 hours)**
  
- In addition to the above specified fees per meter or fraction, the following extra charge per hour or fraction is applicable till the ship's departure:  
**€ 35.00/guard/hour**

### 3. EXTRA SECURITY CONTROLS

Opening of supplementary gates, or requests for extra shore guards, with a minimum chargeable of 4 hours service per guard: **€ 35.00/guard/hour**

### 4. LUGGAGE HANDLING (extra porters)

- Extra porters for special services between 6:00am and 8:00am of weekdays (Monday to Friday) will be subject to a further charge as follows (min. chargeable: 4 hours per porter):  
**€ 35.00/porter/hour**
- Extra porters for special services between 6:00am and 8:00am on Saturdays and pre-holiday days will be subject to a further charge as follows (min. chargeable: 4 hours per porter):  
**€ 43.00/porter/hour**
- Extra porters for special services between 8:00pm and 6:00am of weekdays (Monday to Saturday), and on Sundays and Holidays (00:00/24:00) will be subject to a further charge as follows (min. chargeable: 4 hours per porter):  
**€ 48.00/porter/hour**

### 5. PROVISIONS / STORES HANDLING

Any provisions or stores handling in the area managed by the concessionaire must be carried out by using the concessionaire's personnel and equipment, at the following tariffs:

#### • EQUIPMENT

- Forklift (max capacity: 3.5 tons) with driver (4 hours, minimum chargeable): **€ 450.00**
- Supplementary hours: **€ 77.00/hour**
- Saturdays and pre-holiday days **10% surcharge**
- Sundays and Holidays **20% surcharge**
- From 8:00pm till 8:00am **15% surcharge**
- Manual pallet jack: on request

#### • MANPOWER

- Monday to Friday, from 8:00am till 8:00pm, with a minimum chargeable of 4 hours:  
**€ 35.00/hour/longshoreman**
- On Saturdays and pre-holiday days, from 8:00am till 8:00pm, with a minimum chargeable of 4 hours:  
**€ 43.00/hour/longshoreman**
- On Sundays and Holidays (00:00/24:00), and from 8:00pm till 8:00am on weekdays (Mondays to Saturday), with a minimum chargeable of 4 hours:  
**€ 48.00/hour/longshoreman**

#### • PROVISIONS HANDLING WITH K9 SERVICE

For provisions handling with K9 service, performed with the following personnel and equipment:

- 1 forklift (max capacity: 3.5 tons) with driver
- 2 longshoremen
- 1 shore security guard with an ETDS device for the detection of explosive substances (sniffer)

The following SPECIAL LUMPSUM tariffs apply:

- Monday to Friday, from 8:00am till 8:00pm - 4 hours (minimum chargeable) **€ 900.00**
- Supplementary hours **€ 190.00/hour**
- Saturdays and pre-holiday days **10% surcharge**
- Sundays and Holidays **20% surcharge**
- From 8:00pm till 8:00am **15% surcharge**
